Urge Congress to Finalize FY 2025 NIH Appropriations Before Funding Expires!

ASHG Responds to Department of Justice Proposed Rule



ASHG recently responded to the U.S. Department of Justice (DOJ)'s Notice of Proposed Rulemaking (NPRM), which would implement Executive Order 14117 to prevent countries of concern from accessing Americans' personal data, including restricting transfers of human genetic data. ASHG noted that this NPRM could place significant and unnecessary restrictions on U.S. researchers, limiting already heavily secured and regulated global data sharing.
